2. The minutes of the meeting held on Monday 14th January 2019 were agreed and signed.
3. Matters arising from the minutes:-
 - a) SGC have been notified of the decision not to raise the Annual Precept for 2019-2020.
 - b) BL contacted SGC regarding the proposed Cold Ashton Traffic Control Scheme (KF153). As yet no decisions have been taken.
4. Clerks Report.
 - a) Bank Balances: Current a/c £6269.03. Deposit a/c £2761.25.
5. Items for Payment: - ALCA annual subscription due in May 2019 - £34.29
6. New Planning Applications.
 - a) P19/2214/TCA:- Shaplands House, High Street, Cold Ashton, S. Glos;- Works to fell 3no. Pine trees in Cold Ashton Conservation Area:- Approved by the Parish Council.
 - b) P19/1060/TCA:- Thatched Cottage, Hydes Lane, Cold Ashton, S. Glos;- Works to crown lift 1no. Ash tree to 3.5m, severe ivy at the base and reduce the lever arm limbs by 8m, situated in the Cold Ashton Conservation Area:- Approved by the Parish Council.
 - c) P19/1191/F:- Toghill Barn Farm, London Road, Wick, S. Glos:- Change of use of 3no. agricultural buildings to: shop/cafe (building 1); crafts/workshop/display room (building 2); and, toilets/storage (building 3). Erection of covered walkway between building 1 and 3 and alterations to access and associated works. (sui generis). (Amendments to previously approved scheme PK18/0221/F;- Approved by the Parish Council.

 - a) PK18/6427/TRE:- Quarry Wood, Battlefield, Lansdown, Bath, S. Glos:- Works to trees as the applicants proposed schedule. APPROVED WITH CONDITIONS.
