2. The minutes of the meeting held on Monday 11th March 2019 were agreed and signed.
3. Matters arising from the minutes:-
 - a) Proposed Cold Ashton Traffic Control Scheme (KF153). - Email from Chris Harris (SGC) dated 8/4/2019. notifying us that the Cold Ashton residents proposed partial closure of entrances into Cold Ashton had been turned down. However, the scheme will remain available for selection from 2020/2021 onwards. SGC are allocating expenditure on investigating a 20mph speed limit through Cold Ashton village (scheme KF59). This has been approved as part of the 2019/2020 Capital Programme.
