This has been installed on the front of Cold Ashton Parish Hall. We have since trained 26 people from the parish in CPR and using the new defibrillator. This was with the help of the secretary of the Parish Hall Committee, who organised the two training sessions. The defibrillator is being checked weekly by the lady who cleans the Parish Hall. She reports to BL monthly that it is in working order who then, informs the South West Ambulance Service. (Final costs, see Clerks Report)
