

MINUTES OF MEETING: COLD ASHTON PARISH COUNCIL. MONDAY 9<sup>TH</sup> SEPTEMBER 2019

1. Apologies. – Ben Stokes.

2. The minutes of the meeting held on Monday 8<sup>th</sup> July 2019 were agreed and signed.

3. Matters arising from the minutes:-

a) BL has managed to obtain a grant from the British Heart Foundation (BHF) towards the cost of a defibrillator and CPR training equipment, which has been delivered.

We now have to purchase an external heated defibrillator cabinet which cannot be locked. When installed we then have to register it with the South West Ambulance Service and organise a two hour training session in the Parish Hall for 8-10 people. Bridget Gorringer, who is the secretary of the Parish Hall Committee has volunteered to arrange this. (See items for payment for more information)

4. Clerks Report.

a) Bank Balances: Current a/c £5900.21. Deposit a/c £2764.01.

5. Items for Payment: - £600 paid to the British Heart Foundation for an Intelligent Public Access Defibrillator (IPAD), normal price £1000-£1100 plus, Call, Push, Rescue (CPR) training equipment, worth about £400. We now have to purchase an external unlockable heated defibrillator cabinet which could cost £500 plus vat. Then organise a two hour training session at a cost of £150 plus vat. The Parish Hall Committee have agreed to donate 50% of the total costs.

6) New Planning Applications:-

a) P19/11469/CLE: - Barn at Brook Cottage, Hall Lane, Lower Hamswell. BA19DE – Continue use of building as ancillary residential outbuilding (Class 3). No objection

b) P19/09469/F: - Land at Juniper Lodge, Gloucester Road, Nimlett. SN14 8JX – Erection of extension to existing agricultural building and associated works. No objection

c) P19/09937/TCA: - The Old Rectory, Hydes Lane, Cold Ashton. S. Glos- Works to crown lift to 4.5 metres 1 no. Box Elder and crown lift 2 no. Yew Trees by 20.5 metres. No objection.

7. Planning Applications - Notices of decisions by South Gloucestershire Council.

a) P19/2804/F & P19/2805/LB: - Shaplans House, High Street, Cold Ashton. – Conversion of curtilage listed outbuilding to residential annex ancillary to Shaplans House. APPROVED.

8. Correspondence for Discussion:-

a) The Chestnuts, Cold Ashton - Plan to install 5 x Shepherds Huts on the property for holiday lets was shown to the Parish Council. – It was agreed that the owners must ask for planning permission.

9. A.O.B.-

a) Traffic measuring cables (x3) were installed in Cold Ashton for one week. We are waiting for the results.

b) New 'Website Accessibility Regulations' must be put in place by September 2020.
